With the goals of increasing the transparency of our supply chain, taking on a greater responsibility to ensure good labor conditions, and addressing issues concerning human rights and the environment, Fast Retailing discloses information on our production partners on the company website. We have been publishing and updating annually a list of core garment factories* since 2017. As of March 2022, the list includes all garment factories with whom we expect to continue business relationships.

In addition, we are increasing the mapping and traceability of the supply chain. We publish a list of fabric mills that have been continuously producing materials for our products as well as the factories that garment factories outsource some processes to (washing, printing, etc.).
