AIRBNB MODERN SLAVERY AND HUMAN TRAFFICKING STATEMENT

Airbnb UK Limited, Airbnb Payments UK Limited, and Airbnb Ireland UC are publishing this statement consistent with section 54 of the Modern Slavery Act 2015. This statement covers the financial year ending 31 December 2021 for Airbnb UK Limited, Airbnb Payments UK Limited, and Airbnb Ireland UC. It sets out the steps taken to ensure that modern slavery is not present in our UK business and supply chain. For the purposes of this statement, the term 'modern

slavery' encapsulates slavery, servitude, forced or compulsory labour, and human trafficking.

OUR BUSINESS, STRUCTURE AND SUPPLY CHAIN

Airbnb is a platform connecting hosts and guests across 100,000 cities and in over 220 countries and regions. Since it was founded in 2008, over 1 billion guest arrivals occurred at Airbnb listings around the world and over 4 million hosts have shared their accommodations on our platform (as of September

2021).

Airbnb has offices in 25 cities globally and employs approximately 8,000 people, including approximately 95 people working at our UK office in London. Our

ultimate parent company is Airbnb, Inc. which is based in San Francisco, California.

Part of our UK business is office-based; its supply chain provides a range of goods and services in support of office operations (including the provision of IT and technology, professional services, and business travel) and marketing services. The other part of our UK business provides payment processing services

and its supply chain provides a range of services in support of payments processing and related compliance (including the provision of IT and technology and

professional services).

Our policies on modern slavery

Our Code of Ethics and employment handbook reflect our commitment to ethical business practice and corporate citizenship. We ensure consistent messaging of these policies is distributed throughout our business and management at all levels, as well as in our supply chain. Our core values and policies reflect our recognition of and

Airbnb will not tolerate modern slavery in our supply chain or in any part of our business. We are committed to ensuring that there is transparency in our own

respect for human rights as informed by internationally recognized standards such as the Universal Declaration of Human Rights and the United Nations Guiding Principles on Business and Human Rights (UNGPs). In 2021, we updated our Master Services Agreement to explicitly identify the U.K. Modern

Slavery Act as a law our suppliers may have to comply with.

DUE DILIGENCE AND STEPS TAKEN TO ELIMINATE RISKS

Having assessed our supply chain, and given the nature and scale of our business and supply chain, we consider the risk of modern slavery in our UK supply chain to be low. We have rigorous employment and procurement policies and practices, and we have no evidence to suspect that modern slavery is present within our supply chain. Our procurement process requires all suppliers to our UK business to provide information on their policies and procedures to prevent

modern slavery. We have not received in fiscal year 2021 any information from our suppliers that suggests modern slavery is present in our supply chain. We

would investigate any information that suggests modern slavery is present in our supply chain.

While conduct that occurs on the Airbnb platform is not part of our UK supply chain, we are committed to preventing modern slavery from occuring on the

platform. We regularly publish statements in our newsroom describing the work we do to prevent modern slavery from occuring on the Airbnb platform.

TRAINING AND REPORTING CONCERNS

Employees are trained on an ongoing basis on topics relating to ethics and compliance. We will continue to identify ways to improve employee and supplier awareness of our efforts to eliminate modern slavery from our business and supply chain. We will continue to identify best practices and information that can

be applied to our business and supply chain.

Airbnb maintains a hotline that allows employees to report concerns, including concerns related to the presence of modern slavery. Airbnb has a

Whistleblower Policy that prohibits retaliation against anyone who raises a concern. Reports are investigated according to Airbnb policy and procedure.

OUR EFFECTIVENESS IN ELIMINATING MODERN SLAVERY

We will periodically review the effectiveness of the measures we take in ensuring that there is no modern slavery in our supply chain, and we will use the

results of that review to inform the development of our procedures and best practices.
