Therefore, we encourage the development of hazardous chemicals management in our supply chain, as the best way to be in compliance and even anticipate all future chemicals regulations.

As suppliers of LVMH Maisons, you received a commitment that we ask you to sign and return. The commitment of our suppliers is essential to create an awareness and a dialog about these complex topics. But we are committed to provide with as much guidance as we can.

You'll find in this page documents that are designed to provide you with a technical information as well as our targets as a Group to help you integrate these concerns in your operations and reduce/eliminate the use of these hazardous chemicals in our products.

You'll find all the chemicals regulated in Europe, US and Asia that are relevant for our products range; and the materials in which they can be found. You'll have thus the list of all the REACH Substances of Very High Concern (SVHC). As a reminder, we ask you to respect <0,1% of concentration (mass/mass) of each of these chemicals in every article or sub-parts of articles supplied to us.

This document describes our targets for Fashion and leather goods, and Watches Maisons.

We have identified all the strictest requirements worldwide to make sure our products can be sold everywhere. We added as well some chemicals that are not yet regulated but because of their properties they are being under scrutiny of media, NGO and finally will be regulated in Europe, US, China... in the coming years.

The first page describes our expectations, the second one is an annex with details of most regulations for fashion, leather goods and watches articles worldwide, and the third is the change log.

Being able to control the content of hazardous chemicals present in the materials you supply to us, or the final article we distribute is essential. We encourage a culture of frequent, statistical control on development and production stages.

But testing is an important budget that needs to be optimized. That's why we have developed with the best testing laboratories worldwide testing agreements, that focus on the most critical chemicals per type of materials and treatments (textile, leather, coated canvas, plastic, metal, paper, auxiliaries)

For sure, each Maison has its expectations in terms of testing frequency, content and laboratory, so please refer to your contact to know what is expected from your in terms of providing testing reports.
