Unite collectively represents grades 1-5 (up to LGIM grade 4) and has membership of 33.98% within this group. We saw continuous growth in key areas including Birmingham, Hove, Cardiff and London throughout 2019. On-going recruitment and Unite membership penetration has been impacted by high employee turnover and multiple redundancies and TUPE transfers during 2019. The sale of the General Insurance Division at the end of 2019 and the anticipated sales of the Mature Savings business during 2020 will significantly impact the Unite membership. However, we are hopeful that a full refresh and reinvigoration of our unique partnership in 2020 and 2021 will enable a more positive level of both membership and interaction with L&G.

Unions in US do not apply.

US do not operate in a union or collective bargaining environment. We do comply with the Federal WARN Act (The Worker Adjustment and Retraining Notification Act). The Federal WARN Action offers protection to employees (and families) by requiring employers to provide notice 60 days in advance of covered plant closing and covered mass layoffs. The notice is given to affected workers or their representatives (union environments); to the appropriate state dislocated worker unit and the appropriate unit of local government.

Mass layoff defined – A covered employer must give notice if there is to be a mass layoff which does not result from a plant closing, but which will result in an employment loss at the employment site during any 30-day period for 500 or more employees, or for 50-499 employees if they make up at least 33% of the employer's active workforce.
